During start-up, a gradual change from a standstill to operating state is recommended as follows:</li> <li>Feed pressure should be increased gradually over a 30-60 second time frame.</li> <li>Cross-flow velocity at set operating point should be achieved gradually over 15-20 seconds.</li> <li>Permeate obtained from first hour of operation should be discarded.</li> </ul>
General Information	<ul> <li>Keep elements moist at all times after initial wetting.</li> <li>If operating limits and guidelines given in this bulletin are not strictly followed, the limited warranty will be null and void.</li> <li>To control biological growth during prolonged system shutdowns, it is recommended that membrane elements be immersed in a preservative solution.</li> <li>The Customer is fully responsible for the effects of incompatible chemicals and lubricants on elements.</li> <li>Maximum pressure drops are 15 psi (1.0 bar) per element or 50 psi (3.4 bar) per multi element pressure vessel (housing) which ever value is more limiting.</li> <li>Avoid static permeate-side backpressure at all times.</li> </ul>
