

## Hydraulic Characteristics

Estimated bed expansion of AmberLite<sup>™</sup> IRC200 Na Ion Exchange Resin as a function of backwash flowrate and temperature is shown in Figure 1.

Estimated pressure drop for AmberLite<sup>™</sup> IRC200 Na as a function of service flowrate and temperature is shown in Figure 2. These pressure drop expectations are valid at the start of the service run with clean water and a well-classified bed.
